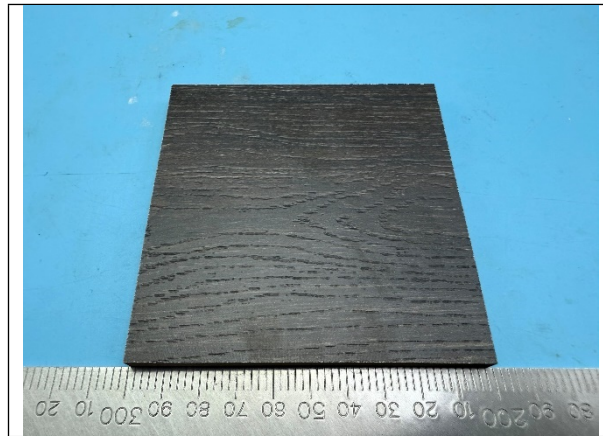

Sample Description: See photo

Test Method: EN 1399:1997+AC:1998

Test Condition:

Specimen: 100mm×100mm, 3pcs

Precondition: at (23±2)°C, (50±5)%RH for 24h.

Method A: Light one end of a cigarette and draw air through it until 10 mm has been consumed. Place the smouldering cigarette(s) in position on the surface of the specimen(s), with full-length contact with the horizontal surface; The cigarettes shall be allowed to burn for a further 20 s. Apply the load to keep the lighted cigarette butt in place. Rotate the specimen(s) through 90° within 2 s and remove the load.
